### **Section 1: Federal Requirements**

<b>FR1 - Includes goals for nutrition education that are designed to promote student wellness.</b>	
Federal Rule language states that policies must include "specific goals for nutrition promotion and education, physical activity, and other school-based activities that promote student wellness."	
<b>N/A</b>	Not applicable
<b>0</b>	Either no goals for nutrition education are mentioned or policy clearly detracts from requirement
<b>1</b>	<p>Any of the following:</p> <ul style="list-style-type: none"><li>• Nutrition education goal is implied</li><li>• Policy only repeats the language of the federal wellness requirement regarding nutrition education</li><li>• Policy only mentions "total learning environment" language and no other NE-related language included</li></ul> <p>Examples:</p> <ul style="list-style-type: none"><li>• "The district is committed to nutrition education"</li><li>• "Includes goals for nutrition education...designed to promote student wellness in a manner that the local education agency deems is appropriate" (no other NE goals stated)</li><li>• "Enable students, through a comprehensive curriculum, to acquire the knowledge and skills necessary to make healthy lifestyle choices."</li></ul>
<b>2</b>	<p>Clear that there are specific goals for nutrition education.</p> <p>Example: "Nutrition lessons are integrated into the curriculum and the health education program."</p>
<b>FR2 - Assures compliance with USDA nutrition standards for reimbursable school meals.</b>	
Federal Rule language states that local educational agencies must set "standards and nutrition guidelines for all food and beverages sold to students during the school day" that "are consistent with applicable requirements set forth under 210.10." Additionally, the WIC Reauthorization Act of 2004	

<p>states that all wellness policies must "provide an assurance that guidelines for reimbursable school meals shall not be less restrictive than regulations and guidance issued by the Secretary of Agriculture."</p>	
<b>N/A</b>	Not applicable
<b>0</b>	Not mentioned
<b>1</b>	<p>Policy states that school meals will meet or are in compliance with USDA nutrition standards but does not link to or cite the nutrition standards</p> <p>Example: "...all foods sold/served on campus will meet USDA nutrition standards for school meals "</p>
<b>2</b>	<p>USDA standards are included in the policy or a working link to the USDA website is provided</p> <p>Example: "Meals served through the district's food services program shall comply with the National School Lunch and/or Breakfast standards for meal patterns, nutrient levels, and calorie requirements for the ages/grade levels served, as specified in 7 CFR 210.10 or 220.8, as applicable. (working links provided)"</p>
<p><b>FR3 - District takes steps to protect the privacy of students who qualify for free or reduced priced meals.</b></p>	
<p>The National School Lunch Act puts restrictions on how much information can be shared from participants. The United States Department of Agriculture states "school food authorities must assure that a child's eligibility status is not disclosed at any point in the process of providing free or reduced-price meals, including notification of the availability of free or reduced-price benefits, certification and notification of eligibility, provision of meals in the cafeteria, and the point of service."</p>	
<b>N/A</b>	District/school/institution qualifies for community eligibility
<b>0</b>	Not mentioned
<b>1</b>	<p>Vague/suggested</p> <p>Example: "The district should take steps to ensure that students qualifying for free or reduced priced meals are not overtly identified in any way."</p>
<b>2</b>	<p>District has implemented plans to protect student privacy which include methods used (in addition to following relevant regulations) OR district provides universal free school meals</p> <p>Example: "The cafeterias are cashless—all students, regardless of the type of payment they make for school meals, or the food being purchased (meal or a la carte) are given a code to enter at the cash register."</p>
<p><b>FR4 - Free drinking water is available during meals.</b></p>	
<p>Federal Rule language states that schools "must make potable water available to children at no charge in the place where lunches are served during the meal service, consistent with amendments made by section 203 of the HHFKA, and in the cafeteria during breakfast meal service."</p>	
<b>N/A</b>	Not applicable
<b>0</b>	Not mentioned
<b>1</b>	<p>Drinking water is available, but accessibility is unclear</p> <p>Examples:</p> <ul style="list-style-type: none"> <li>• "Drinking water is available in the cafeteria upon request."</li> <li>• "Water should be available in the cafeteria."</li> </ul>

	<p>Free drinking water is available for self-service in the cafeteria</p> <p>Examples:</p> <p><b>2</b></p> <ul style="list-style-type: none"> <li>• "Water fountains or water filling stations are available in all cafeterias."</li> <li>• "Water jugs and cups will be present in the cafeteria and supervisory staff will allow students to access water throughout the meal period."</li> <li>• "Free water will be available in the cafeteria during meal times."</li> </ul>
<b>FR5 - Ensures annual training for food and nutrition services staff in accordance with USDA Professional Standards.</b>	
	<p>Training requirements include: new and current directors: 12 hours; new and current managers: 10 hours; new and current staff: 6 hours. Requirement information available at: <a href="https://www.gpo.gov/fdsys/pkg/FR-2015-03-02/pdf/2015-04234.pdf">https://www.gpo.gov/fdsys/pkg/FR-2015-03-02/pdf/2015-04234.pdf</a>.</p>
<b>N/A</b>	Not applicable
<b>0</b>	Not mentioned
	Training suggested, but unclear if USDA requirement is met
<b>1</b>	<p>Examples:</p> <ul style="list-style-type: none"> <li>• "All food service personnel will have adequate training in food service operations."</li> <li>• "All food service personnel shall receive pre-service training in food service operations."</li> </ul>
<b>2</b>	<p>It is clear that USDA requirement for training and/or continuing education is being met</p> <p>Examples:</p> <ul style="list-style-type: none"> <li>• "The USDA Professional Standards for State and Local Nutrition Programs are followed to ensure that professional development in the area of food and nutrition is provided for food service directors, managers and staff. New and current food service directors must have at least 12 hours; new and current managers must have at least 10 hours; new and current staff must have at least 6 hours"</li> <li>• "All school nutrition program directors, managers and staff will meet hiring and annual continuing education/training requirements in the USDA Professional Standards for Child Nutrition Professionals. These school nutrition personnel will refer to USDA's Professional Standards for School Nutrition Standards website to search for training that meets their learning needs."</li> </ul>
<b>FR6 - Addresses compliance with USDA nutrition standards (Smart Snacks) for all food and beverages sold to students during the school day.</b>	
<p>Federal Rule language states that policies must contain "standards and nutrition guidelines for all foods and beverages sold to students during the school day on each participating school campus under the jurisdiction of the local educational agency." The school day begins at midnight the night before and goes until 30 minutes after the final bell.</p>	
<b>N/A</b>	Not applicable
<b>0</b>	Not mentioned
<b>1</b>	<p>Vague and/or suggested. Any of the following:</p> <ul style="list-style-type: none"> <li>• Specifies meeting nutrition standards for competitive foods, but does not show: specific standards that document compliance OR specify USDA Smart Snacks OR specify federal requirements.</li> <li>• Lists some, but not all standards/ implies partial compliance</li> </ul>

	<ul style="list-style-type: none"> <li>Requires Smart Snacks for foods or beverages, but not both</li> </ul> <p>Examples:</p> <ul style="list-style-type: none"> <li>"All foods sold to students outside of school meals shall meet district nutrition standards." (district nutrition standards do not meet Smart Snacks)</li> <li>"All beverages sold must meet Smart Snack nutrition standards."</li> </ul>

<b>FR7 - Regulates food and beverages sold in a la carte.</b>	
N/A	Not mentioned or language such as "The district shall monitor all food and beverages sold or served to students, including those available outside of the federally regulated child nutrition programs." (i.e., a la carte, vending, student stores, rewards, fundraising, etc.)

1	<p>Recommended/limited to either of the following:</p> <ul style="list-style-type: none"> <li>A la carte regulations or umbrella statement regulating "all (competitive) foods" is vague, suggested, time- or location- specific, subject to principal's discretion, or weakened by other exceptions</li> <li>A la carte nutrition standards are required, but do not meet the level of Smart Snacks</li> </ul> <p>Examples:</p> <ul style="list-style-type: none"> <li>"Food service shall strive to include some healthy choices (choices listed) for all a la carte food sales."</li> <li>"All foods and beverages sold must meet nutrition standards for fat, sugar, and calories. #### FR8 - Regulates food and beverages sold in vending machines.

0	<p>Not mentioned or language such as "The district shall monitor all food and beverages sold or served to students, including those available outside of the federally regulated child nutrition programs." (i.e., a la carte, vending, student stores, rewards, fundraising, etc.)</p>
1	<p>Recommended or limited to either of the following:</p> <ul style="list-style-type: none"> <li>• Vending machine regulations or umbrella statement regulating "all (competitive) foods" is vague, suggested, time- or location- specific, subject to principal's discretion, or weakened by other exceptions</li> <li>• Vending machine nutrition standards are required, but do not meet the level of Smart Snacks</li> </ul> <p>Examples:</p> <ul style="list-style-type: none"> <li>• "Food service shall strive to include some healthy choices (choices listed) for all a la carte food sales."</li> <li>• "All foods and beverages sold must meet nutrition standards for fat, sugar, and calories. Only water, milk, and 100% juice may be sold." (requirements don't meet Smart Snacks)</li> </ul>

#### FR9 - Regulates food and beverages sold in school stores.

0	<p>Not mentioned or language such as "The district shall monitor all food and beverages sold or served to students, including those available outside of the federally regulated child nutrition programs." (i.e., a la carte, vending, student stores, rewards, fundraising, etc.)</p>

<b>1</b>	<p>Recommended or limited to either of the following:</p> <ul style="list-style-type: none"> <li>• School store regulations or umbrella statement regulating "all (competitive) foods" is vague, suggested, time- or location-specific, subject to principal's discretion, or weakened by other exceptions</li> <li>• School store nutrition standards are required, but do not meet the level of Smart Snacks.</li> </ul> <p>Examples:</p> <ul style="list-style-type: none"> <li>• "Food service shall strive to include some healthy choices (choices listed) for all a la carte food sales."</li> <li>• "All foods and beverages sold must meet nutrition standards for fat, sugar, and calories. Only water, milk, and 100% juice may be sold." (requirements don't meet Smart Snacks)</li> </ul>
<b>2</b>	<p>Requires either of the following:</p> <ul style="list-style-type: none"> <li>• Smart Snacks</li> <li>• Competitive food and beverage sales are banned during the school day (or just within school stores)</li> </ul> <p>If a policy requires that "all food sold" or "all food and beverages made available" meet Smart Snacks standards, or competitive foods are not allowed to be sold, FR9 should be coded as a 2.</p> <p>Examples:</p> <ul style="list-style-type: none"> <li>• "It is the policy of the School District that all foods and beverages sold to students during the school day on any property under the jurisdiction of the district will meet the U.S. Department of Agriculture (USDA) school meal and Smart Snacks in School (Smart Snacks) nutrition standards."</li> <li>• "All food items served or offered (for sale) to students during the school day (from the midnight prior, to 30 minutes after the end of the official school day) will meet all federal, state, and local standards for all nutrient and competitive food guidelines."</li> <li>• "This district does not allow for the operation of school stores until 30 minutes after the end of the school day."</li> <li>• "No competitive foods or beverages may be sold during the school day."</li> </ul>
<b>FR10 - Addresses fundraising with food to be consumed during the school day.</b>	
<p>Smart Snacks applies to food and beverages sold as fundraisers during the school day. State agencies may adopt a policy that allows for exemptions to this requirement for infrequent school-sponsored fundraisers. Item NES9 will capture whether or not those exemptions apply.</p>

<b>0</b>	<p>Not mentioned or language such as "The district shall monitor all food and beverages sold or served to students, including those available outside of the federally regulated child nutrition programs. (i.e., a la carte, vending, student stores, rewards, fundraising, etc.)</p>
<b>1</b>	<p>Recommended or limited to either of the following:</p> <ul style="list-style-type: none"> <li>• Fundraiser regulations or umbrella statement regulating "all (competitive) foods" is vague, suggested, time- or location-specific, subject to principal's discretion, or weakened by other exceptions</li> <li>• Fundraiser nutrition standards are required, but do not meet the level of Smart Snacks.</li> </ul>

	Example: "Food service shall strive to include some healthy choices (choices listed) for all fundraisers."
	<p>Requires either:</p> <ul style="list-style-type: none"> <li>• Smart Snacks</li> <li>• Competitive food and beverage sales are banned during the school day (or just fundraisers)</li> </ul> <p>If a policy requires that "all food sold" or "all food and beverages made available" meet Smart Snacks standards, or competitive foods are not allowed to be sold, FR10 should be coded as a 2.</p>

<b>FR11 - Regulates food and beverages served at class parties and other school celebrations in elementary schools. Use N/A if no elementary schools in district.</b>	
N/A	Not applicable
0	Not mentioned OR the foods and beverages served are specifically exempted from any district nutrition standards.
1	<p>Any of the following:</p> <p>Regulations for class parties are required but weakened (e.g., by allowing one traditional party food.)</p> <p>Provide a specific and restricted list of food items allowed to be served/distributed/available at class parties or at all times (e.g., limiting to fruits and whole grains).</p> <p>Examples:</p> <ul style="list-style-type: none"> <li>• "The district shall provide parents with a list of allowable party foods that meet the Smart Snack standards."</li> <li>• "The district will regulate all food and beverages served during classroom activities."</li> <li>• "Classroom parties, celebrations, etc. shall be limited to one snack and one beverage from a list of Smart Snack allowable items."</li> </ul>

**FR12 - Restricts marketing on the school campus during the school day to only those foods and beverages that meet Smart Snacks standards.**

Federal Rule language states that schools may only "permit marketing on the school campus during the school day of those foods and beverages that meet the nutrition standards under 210.11 and promote student health and reduce childhood obesity." School marketing includes the name or depiction of products, brands, logos, trademarks, or spokespersons or characters, on any property or facility owned or leased by the school district or school. This includes any facilities used during the school day for school-related activities including school buildings and campus; outside and areas adjacent to school buildings; athletic fields; school buses; and parking lots. Note that marketing can be found in many locations, including: signs, scoreboards, sports equipment; curricula, textbooks, websites used for educational purposes, or other educational materials (both printed and electronic); exteriors of vending machines, food or beverage cups or containers, food display racks, coolers, trash and recycling containers, etc.; advertisements in school publications, on school radio stations, in-school television, computer screen savers and/or school-sponsored Internet sites, or announcements on the public announcement (PA) system

<b>1</b>	<p>Vague or suggested or restricts marketing to district nutrition standards that do not rise to the level of Smart Snacks</p> <p>Examples:</p> <ul style="list-style-type: none"> <li>“Food service providers should be sensitive to the nutrition environment when displaying logos/trademarks on school grounds.”</li> <li>“Marketing on the school campus will be limited to those products that are allowed to be sold according to the district’s nutrition standards.” (district nutrition standards do not meet Smart Snacks)</li> </ul>
<b>2</b>	<p>Restricts marketing of foods and beverages on the school campus, during the school day to those items that meet Smart Snacks</p> <p>Examples:</p> <ul style="list-style-type: none"> <li>“School-based marketing shall be consistent with Smart Snacks nutrition standards.”</li> <li>“Marketing on the school campus will be limited to those products that are allowed to be sold according to the district’s nutrition standards.” (district nutrition standards require Smart Snacks)</li> </ul>

**FR13 - Addresses how all relevant stakeholders will participate.**

The Federal Rule language states that the policy must include "a description of the manner in which parents, students, representatives of the school food authority, teachers of physical education, school health professionals, the school board, school administrators, and the general public are provided an opportunity to participate in the development, implementation, and periodic review and update of the local school wellness policy."

<b>1</b>	<p>Recommends that membership is open to the community, or requires fewer than all listed stakeholders</p> <p>Example: "Students, parents, staff and/or community members are welcome to join the committee."</p>
<b>2</b>	<p>States a plan to actively recruit some or all of the following: Parents, students, PE teachers, school food authority representatives, school health professionals, school board members, administrators, members of the general public.</p> <p>Example: "A letter will be sent to the school community via email, and will be posted in a central area in all school buildings inviting members of the community to join the wellness committee. Parents, students, representatives of the school food authority, PE teachers, school health professionals, the school board, school administrators, and the general public will be included in the development, implementation, review and update of the wellness policy."</p>
<b>FR14 - Identifies the officials responsible for compliance with all components of the local wellness policy in each school.</b>	
<p>Federal Rule language states that each local educational agency must "designate one or more local educational agency officials or school officials to ensure that each participating school complies with the local school wellness policy."</p>

<b>0</b>	<p>Not mentioned</p>
<b>1</b>	<p>It is suggested, but not required, that a district official be responsible for monitoring school-level compliance</p> <p>Examples:</p> <ul style="list-style-type: none"> <li>• "School principals should periodically update the superintendent on school-level compliance with the district wellness policy."</li> <li>• "A district and school contact will be designated with the responsibility to ensure that the schools meet this policy."</li> </ul>
<b>2</b>	<p>It is clear that a district official (including the name or position of an individual) will be responsible for ensuring compliance in each school building.</p> <p>Examples:</p> <ul style="list-style-type: none"> <li>• "The assistant superintendent shall be responsible for ensuring that the wellness policy is implemented throughout district schools."</li> <li>• "The Superintendent or designee shall ensure compliance with established district wide nutrition and physical activity policies. In each school, the building administrator or designee shall ensure compliance."</li> </ul>
<b>FR15 - Addresses making the wellness policy available to the public.</b>	
<p>Federal Rule language states that local educational agencies must "inform the public about the content and implementation of the local school wellness policy, and make the policy and any updates to the policy available to the public on an annual basis."</p>	
<b>N/A</b>	<p>Not applicable</p>
<b>0</b>	<p>Not mentioned</p>
<b>1</b>	<p>Either of the following:</p>

	<ul style="list-style-type: none"> <li>• Vague and/or suggested</li> <li>• The wellness policy is available upon request</li> </ul> <p>Example: "The district will ensure school and community awareness of this policy by making it available by request."</p>
2	<p>Requires district to post its wellness policy on the website or distribute the wellness policy to the school and community on an annual basis at a minimum</p> <p>Example: "All public schools and public charter schools shall promote their local wellness policy to faculty, staff, parents, and students. A copy shall be posted on each school's website."</p>
<b>FR16 - Addresses the assessment of district implementation of the local wellness policy at least once every three years.</b>	
Federal Rule language states that local educational agencies must "at least once every three years, assess schools' compliance with the local school wellness policy, and make assessment results available to the public."	
<b>N/A</b>	Not applicable
<b>0</b>	Not mentioned
1	<p>Either of the following:</p> <ul style="list-style-type: none"> <li>• It is suggested that policy implementation will be assessed</li> <li>• Implementation will be assessed, but less than triennially</li> </ul> <p>Example: "Representatives from each school should track compliance with the district SWP within their school."</p>
2	<p>There is a specific plan to assess implementation compliance at least once every three years.</p> <p>Example: "The Advisory Council shall conduct a quantitative assessment of policy implementation every three years using the Wellness School Assessment Tool - Practice (WellSAT Practice) or the School Health Index."</p>
<b>FR17 – Addresses making triennial assessment results available to the public and specifies what will be included.</b>	
When shared with the public, triennial assessment results must include the extent to which schools under the jurisdiction of the LEA are in compliance with the local school wellness policy; the extent to which the LEA's local school wellness policy compares to model local school wellness policies; and a description of the progress made in attaining the goals of the local school wellness policy.

<b>0</b>	Not mentioned
1	<p>Specifies inclusion of some, but not all, triennial progress report elements</p> <p>Example: "A triennial progress report with information about each school's wellness related activities will be shared with the entire school community."</p>
2	<p>Includes a statement making it clear that all three elements listed above will be included in the triennial progress report</p>

	Example: "The triennial progress report will be posted on the district website. The report will include an assessment on compliance, the extent to which our wellness policy compares to model wellness policies, and progress made in achieving goals."
<b>FR18 - Addresses a plan for updating policy based on results of the triennial assessment.</b>	
Federal Rule language states that districts must "make appropriate updates or modifications to the local school wellness policy, based on the triennial assessment."

<b>1</b>	Plans for updating policy are implied, but not certain, OR timing is unclear.  Example: "The district wellness committee will revise the policy as needed"
<b>2</b>	The need for policy revisions is assessed and completed at specified intervals.  Example: "Every three years, the wellness committee will review the latest national recommendations pertaining to school health and will update the wellness policy accordingly."
