## NOTICE OF THE STUDENT ACADEMIC STANDARDS THAT ARE IN EFFECT FOR THE 2018-19 SCHOOL YEAR

August 2018

Dear Parents/Guardians:

Per Wisconsin Act 55, each public school in the state is required to provide annual notices that include student academic standards, Education for Employment Program and academic & career planning services for students. Information is provided below as well as links to the State website that can provide additional information.

### Student Academic Standards

School boards are required by Wisconsin State Statutes section 120.12(13) and section 118.30(1g)(a)1 to notify the parents/guardians of students enrolled in the District of the student academic standards that will be in effect for the school year. Adopted by the School Board in July 2017, the Wisconsin Model Academic Standards will continue to be used to identify student academic standards for mathematics, science, reading and writing, geography and history. Using the Model Academic Standards, staff of the School District of Hartford Jt. 1 map District benchmarks and design curriculum that rigorously meets the high expectations of our local professional learning community under the leadership of a School Board. In addition, the Board approves the selection of textbook adoptions, instructional materials and resources that facilitate the delivery of the curriculum to ensure students meet proficiency levels.

### Student Assessment Information

Wisconsin State Statutes section 118.30(1m)(d) requires districts to provide information of the state-required 4<sup>th</sup> & 8<sup>th</sup> grade examinations given to students in the district. The Every Student Succeeds Act (ESSA) (20 U.S.C. §6312(e)2B) requires Title 1 program districts to notify parents of the option to request information regarding any state or local school district policy regarding student participation in any assessments mandated by law and the district. ### Education for Employment Program

School boards are required by PI26.03 to notify parents of the District's Education for Employment (E4E) program. Under Wisconsin Statutes 121.02(1)(m) and 115.28(59), school districts must provide all students access to an E4E program that provides students in grades 6-12 with information and opportunities that lead to career planning and preparation. The current E4E program includes a long-range plan that was collaboratively developed by a K-12 consortium team and approved by the school board in 2013. The Hartford Area K-12 Consortium Education for Employment Plan is available on the District's website <https://www.hartfordjt1.k12.wi.us>. Education for Employment plans were revised to include Academic and Career Planning (PI26.03) goals beginning with the 2017-2018 school year.

### **Academic & Career Planning Services for Students**

School districts are required by PI 26.03(1)(b)1 to inform parents about the academic and career planning services their child receives. Academic and career planning services 115.28(59)(b) are required to be provided to all students enrolled in grades 6 to 12 beginning with the 2017-2018 school year.

Academic and Career Planning (ACP) is a collaboratively developed, student-driven process for planning academic and career success meant to ensure that all students have the opportunity to direct their learning to provide opportunities that will inform their choices for the future. ACP programs should align with current district Education for Employment plans and include opportunities for self-exploration, career exploration and career planning. Hartford Jt. #1 will use the *Career Cruising* computer software during the school year and will work in partnership with Hartford Union High School to develop an ACP model for grades 6-12. ACP will be incorporated as an integral part of the overall college and career readiness plan (E4E) by training staff in the ACP implementation and delivery model (<http://dpi.wi.gov/acp/implementation>).
