To gain additional feedback and planning input, the District coordinated a Steering Committee made up of HJT1 stakeholders including parents, staff, and school board members. This group invested approximately four to five hours of time reviewing survey data, health and safety recommendations, legal implications, and multiple instructional delivery scenarios.

All members who were present at the final Steering Committee were supportive of the plan to offer multiple instructional delivery options as presented to parents.

# **PARENT & STAFF PLANNING SURVEY RESULTS (JUNE 2020)**

**OVERVIEW:** The Hartford Jt. #1 School District surveyed parents and staff to gather feedback as we planned for the 2020-21 school year. The survey was conducted via email to all parents and staff from June 19 - 28, 2020. It was conducted by School Perceptions LLC.

A total of 1,014 respondents included: 864 parents and 227 staff.

**SPRING:** Parents provided some insight into their experiences this spring during the stay-at-home order.

# In general, how confident were you in supporting your child's learning at home?

51% of families had a parent or other relative available to support learning during the school day.

#### **PLANNING PRIORITIES**

Respondents ranked top 3 planning priorities (in order):

- 1. Ensuring academic progress of students
- 2. Ensuring safety of students and staff
- 3. Supporting students' mental health needs







# **CONSIDERATIONS FOR SCHOOLS** FROM THE (CDC)

#### **Guiding Principles to Keep in Mind**

The more people a student or staff member interacts with, and the longer that interaction, the higher the risk of COVID-19 spread. The risk of COVID-19 spread increases in school settings as follows:

**Lowest Risk:** Students and teachers engage in virtual-only classes, activities, and events.

More Risk: Small, in-person classes, activities, and events. Groups of students stay together and with the same teacher throughout/across school days and groups do not mix. Students remain at least 6 feet apart and do not share objects (e.g., hybrid virtual and in-person class structures, or staggered/rotated scheduling to accommodate smaller class sizes).

**Highest Risk:** Full sized, in-person classes, activities, and events. Students are not spaced apart, share classroom materials or supplies, and mix between classes and activities.

COVID-19 is mostly spread by respiratory droplets released when people talk, cough, or sneeze. It is thought that the virus may spread to hands from a contaminated surface and then to the nose or mouth, causing infection. Therefore, personal prevention practices (such as hand washing, staying home when sick) and environmental cleaning and disinfection are important principles that are covered in this document. Fortunately, there are a number of actions school administrators can take to help lower the risk of COVID-19 exposure and spread during school sessions and activities.

#### **Promoting Behaviors that Reduce Spread**



#### **Physical Distancing**

Social distancing, also called "physical distancing," means keeping a safe space between yourself and other people who are not from your household. To practice social

or physical distancing, stay at least 6 feet (about 2 arms' length) from other people who are not from your household in both indoor and outdoor spaces. Physical distancing should be practiced in combination with other everyday preventive actions to reduce the spread of COVID-19.



# Hand Hygiene and Respiratory Etiquette

Hand washing with soap and water for at least 20 seconds and increase monitoring to ensure adherence among students and staff.

If soap and water are not readily available, hand sanitizer that contains at least 60% alcohol can be used (for staff and older children who can safely use hand sanitizer).

Cover coughs and sneezes with a tissue. Used tissues should be thrown in the trash and hands washed immediately with soap and water for at least 20 seconds.



#### **Cloth Face Coverings**

Face coverings should be worn by staff and students (particularly older students) as feasible, and are most essential in times when physical distancing is difficult. Individuals

should be frequently reminded not to touch the face covering and to wash their hands frequently.



#### **Staying Home when Appropriate**

Students and staff who are sick or who have recently had close contact with a person with COVID-19 should stay home.



#### **Clean & Disinfection**

Clean and disinfect frequently touched surfaces within the school and on school buses at least daily or between use as much as possible. Use of shared objects should

be limited when possible, or cleaned between use.

## **SAFE SPACES**

**Physical barriers** in common spaces and classrooms where advisable.

**Way finding signage** and floor adhesives and in high-traffic areas.

**Safety signage** and education around hand hygiene, protective measures, and symptoms awareness.

**Drinking Fountains** is limited to bottle filling only.

**Optimize classrooms** and common areas to spread out and allow physical distancing as much as possible.

**Safety area** for personal protective equipment when an individual displays possible symptoms.

# HEALTHY ENVIRONMENTS

**Health screenings** of students and staff including daily temperatures.

### **Cleaning & Disinfecting**

protocols will be increased to daily and weekly procedures.

**Shared Objects** will have increased sanitation requirements.

**Common Areas** will have staggered use and increased cleaning protocols.

**Education** and reinforcement of hand hygiene.

#### **Modified building layouts**

including adjusted traffic patterns and relocated classrooms to improve physical distancing.

# **BUILDING OPERATIONS**

#### **Visitors & Volunteers**

Non-essential visitors are restricted. All approved visitors entering the buildings must wear a face covering.

#### **Extra-Curricular Activities**

Temporarily suspended.

#### Field Trips, Events, Meetings

Field trips and large gatherings will be very limited. Parent and staff meetings will be held virtually.

#### **Entrances & Dismissals**

Entrances and exits will be regulated and traffic patterns adjusted. \*Start times and dismissal times may vary slightly by grade level based on busing routes, instruction model selection in order to minimize crossover among children.

#### **Recess**

Recesses will be staggered and with the cohort.



## MITIGATING THE RISKS OF THE SPREAD OF COVID-19

#### **Face Coverings**

**Staff:** Required when within six feet of a student or staff member and when in common areas.

**Students:** Face coverings are expected in areas when distancing is difficult including: classrooms, bus, common areas, restrooms, arrival, and dismissal.

#### **Physical Distancing**

Classrooms will practice physical distancing as much as possible with a full class size.

Students and staff follow operational safety procedures to reduce the spread of COVID-19.

#### **Food Service**

Students will eat with their cohorts as an effort to minimize crossover among children and adults within the schools.

For students participating in homebound, virtual instruction, lunches and breakfast at the regular cost or for free and reduced will be available to pick up at their school.

#### **Busing**

District officials will continue to work with our contracted bus company to confirm the following precautionary measures for all riders:

**Capacity:** Two students per assigned seat/bench when possible (preferably from the same household). Students will load the bus, filling seats from the back to the front.

**Health & Safety:** Hand sanitizer stations on the bus will be provided. Increased daily and weekly cleaning protocols.

**Face Coverings:** Bus driver required. Students expected.



We recommend the use of cloth face masks by members of the general public if access to surgical or N95 masks is limited. While a mask may not be 100% effective in the stop of COVID-19 spread, they are certainly effective in slowing it down and protecting our community members. The effectiveness of masks may vary based on type of mask, cleanliness of mask, how long the mask is worn, and how the mask is worn, but it is by far one of the best and fairly easiest things we can all do to slow the spread of COVID-19.

## **INSTRUCTIONAL MODEL SELECTION PROCESS**

After you have had time to fully review the four Instructional Delivery Models in this plan, we will ask you to select an Instructional Model for each of your children for the upcoming school year. HJT1 families will be asked to select one of the four Instructional Delivery Models for each child in your household. This process will be sent to parents via email in late July, 2020.

#### A commitment to your selection

Due to the level of coordination required by the District to determine staffing for all four models, the district asks that you commit to your selection for at least one trimester (for Rossman & Lincoln students); and one quarter (for CMS students).

If the need for adjusting instructional models arises, please contact the building principal for availability of seats in the face to face and/or hybrid models. \*Please note, changing instructional models may mean your child will not have the same teacher.

Please continue to check your email as we send further email correspondence over the coming days and weeks.

The Instructional Model Selection Process will take place in late July. Families, watch your email for more details.













# FREQUENTLY ASKED QUESTIONS FOR FAMILIES

#### **HEALTH & SAFETY FAQs**

# What health and safety guidelines will be followed for a safe return to school?

We followed recommendations from Washington County Department of Health, Wisconsin DPI Education Forward Plan, Centers for Disease Control and Prevention, and The American Academy of Pediatrics.

#### **Face Coverings:**

Staff: Required when within 6 feet of a student or staff member and when in common areas.

Students: Face coverings are expected in areas when distancing is difficult including: bus, common areas, restrooms, arrival and dismissal.

#### **Physical Distancing:**

Physical distancing will be practiced as much as possible based on class size. This may include: modified classroom and building layouts, adjusted traffic patterns, and relocated classrooms. Students and staff will be asked to follow the operational safety procedures to reduce the spread of Covid-19.

# What happens if there is a positive case of COVID-19 in school?

We ask that parents self-report to the school district in the event of a positive COVID 19 test of your student or in your family. The Department of Health Services will work with the school district to determine the proper follow-up, depending on the situation. Parents will be notified of a positive case in the school building.

# Will my school be quarantined if there is a positive case of COVID-19 in the building?

The county will closely examine contact tracing and safety/health measures in place. Quarantine of a classroom, multiple classrooms, school building, and entire district are a possibility depending on the safety and health precautions that were in place in that classroom (ie: physical distancing, facial coverings, co-mingling, etc.).

# How will you monitor the health of students and staff who are in the buildings?

Teachers will take student temperatures in the morning when they get to school and after lunch. If a student displays symptoms related to Covid-19 they will be sent to a Safety Area within the school building for monitoring and parent contact.

# How will you reduce comingling of students and staff who select the face to face or hybrid instructional model?

As an effort to minimize crossover among children and adults within the schools, the District will implement a Cohort model of instruction for face to face learning. A cohort is a group of students who will learn together throughout the entire school day. Cohorts will be determined based on a student's grade level and their instructional delivery selection.

# How will you reduce comingling of students and staff in common areas?

Students will be spread out as much as possible and rotate use of common areas. There will be increased

use of entrance and exit doors for arrival and dismissal. Students will enter and exit through doors closest to their classrooms. Restroom use will be scheduled with increased cleaning between classrooms and students. Hallways will be clearly marked with a directional flow. Lunch will be brought to the classrooms and primarily eaten within the classroom. There will be a rotating schedule of eating in the lunchroom or other areas. During recess, students will play within their cohorts in designated areas on the playground.

#### **INSTRUCTIONAL MODEL FAQS**

# How do I select an Instructional Model for my child/ren for the fall?

HJT1 families will be asked to select one of the four Instructional Delivery Models for each child in your household. A secure link will be sent to families in their email. Parents are asked to complete their instructional model selection for each of their children promptly to allow the District time to coordinate.

# Can families change their instructional model if it is not a good fit?

Due to the level of coordination required by the District to determine staffing, the District asks that you commit to the selection you make for your child/ren at least one trimester (for Rossman & Lincoln students); and one quarter (for CMS students). If the need for adjusting instructional models arises, please contact the building principal for availability of seats in the face to face and/or hybrid models. Please note, changing instructional models may mean your child may not have the same teacher.



# FREQUENTLY ASKED QUESTIONS FOR FAMILIES (continued)

# Will the District have minimum or maximum enrollment requirements for each of the four instructional models?

At this time, the District does not anticipate having minimum or maximum enrollment requirements for each instructional model. Students will be admitted into the model in which they select prior to the start of the school year. It is important to note that enrollment for each instructional model will drive staffing decisions and assignments; therefore, if numbers are too low or too high for any given model, teachers may be assigned a split grade level to account for total enrollment.

It is also important to note that if a family changes their instructional model selection after the start of the school year, they may not have the same teacher in the new model.

# If a school is quarantined due to Covid-19, which virtual model will face to face students be assigned to?

At the time of the quarantine, students who attend the face to face or hybrid models of instruction will be assigned to the real-time online virtual instruction (Virtual Option B).

If a family selects the self-paced virtual option (Virtual Option A) at the time of quarantine, the student will be asked to remain in the Self Paced Virtual format for the remainder of the school year (due to risk of being out of ahead or behind schedule compared to the rest of the cohort).

# Virtual Model: How will virtual instruction look different compared to the spring?

**Virtual Option A:** Students will access course materials on their own schedule. A teacher will check in with the student regularly. Students will not have any real time instruction.

**Virtual Option B:** Students will meet with their teacher for real time instruction during a daily set schedule. These same lessons will be recorded for any student who occasionally misses class. Curriculum is the Board Approved Curriculum used in the face to face classroom.

# Hybrid Model: Can families with multiple children select if they prefer their children be on the same hybrid schedule vs. opposite?

Yes, the District will make every attempt to assign families to the preferred hybrid schedule.

# Hybrid Model: Can families select either of the two virtual options (Option A vs. Option B) for their child/rens' virtual week?

No, families that choose the hybrid option will access face to face instruction and real-time online lessons (Option B) with the same teacher and cohort of peers on the week they are learning from home.

# Hybrid Model: What does virtual learning look like for students in the hybrid model?

Students in the hybrid model will participate in real time online teacher-facilitated lessons. Students follow a daily class schedule attending virtual instruction Monday - Friday. \*Lessons will be recorded if a student is occasionally unable to attend real-time instruction.

Half of the cohort of students will attend face to face instruction while the other half will participate in the lesson in real time from home. The following week the groups change.

#### Hybrid Model / Synchronous Virtual: Would students be marked absent if they are not present for an online session during the synchronous program.

Students in the hybrid/synchronous virtual model (Option B) will follow normal classroom practices for attendance. If a student is going to knowingly miss a lesson, they are to communicate their absence to the teacher. Student illness would be recorded as an excused absence
